## **Approval of Minutes**

Ben Smith moved to approve the minutes from the August 9, 2022 regular board meeting as amended. Nicole Rasmussen seconded the motion. Motion approved unanimously.

## REPORTS

#### District

Kim Williams highlights for the district that in addition from her activity reports that her Puget Sound Caucus mangers meeting was able to be in person this last month and it was great to be able to meet these managers face to face. The district's annual presentation with Commissioners went well yesterday. In addition to the presentation, there was also conversation regarding stable funding for the district. For an irrigation update, some final paperwork is wrapping up to begin funding for the WaterSMART grant.

Meghan Adamire reported she completed two Conservation Reserve Enhancement Program (CREP) re-enrollment plans for riparian buffers on Matriotti and Lotzgesell Creeks, and completed a CREP plan for a new riparian buffer planting on the Hoko River, however it is currently held up by cultural resources. Cascadia Conservation District has an archeologist on staff she is hoping to utilize to assist with cultural resources on this project, as well as others. An agreement it later in the agenda. Orca Recovery Week coming in October, and she is working with several agencies to plan for multiple educational and volunteer events throughout the county. A question was asked regarding workload for the new salmon riparian field technician position, the district has a list of around 25 landowners/managers that didn't qualify for CREP but may be eligible for this new Riparian Funding.

Jennifer Bond reported that only two bids were obtained for an onsite septic system (OSS) repair project located in Golden Sands despite best efforts by the homeowners. The low bidder for both of the current OSS repair projects is RJ Services. Jen also reported that she and Kim met with Jen Garcelon and Katie Kowal of Clallam County Environmental Health (CCEH) to discuss challenges with the OSS cost share program including lack of referrals from CCEH for the program and continued challenges with the grant funding. CCEH is working to extend this funding source for one calendar year and are hopeful they can hire additional staff soon to help with this program.

NRCS - None.

**WACD** – Alan Chapman shared that the district should have received something from Whidbey regard the regional meeting on Oct 11, 2022. Go to WACD to see the resolutions that are currently under discussion. WACD is working hard to help all those involved to have a better idea on what is expected, what is the intent and when will the resolutions be implemented.

**WSCC** – Jean Fike shared that the commission meeting is next week if anyone would like to attend. Also the Election Training in on Sept 28<sup>th</sup>. The Supervisors are invited to attend, however for sure your district election Supervisor should attend as well as a backup if possible.

ECY – Hannah Coe reminds that the grant closes on October 28<sup>th</sup> we also got a non-agriculture URTs table. Kim questions the water quality grants with a 50% match for OSS repair and asking for connection to be able to dig a little deeper into OSS Funding
