# **Approval of Minutes**

Ben Smith moved to approve the minutes as amended from the regular board meeting held on July 9, 2019. Robert Beebe seconded the motion. Motion approved unanimously.

#### REPORTS

## **Staff Reports**

Jen – Soil moisture monitoring stations were installed on three farms. Four onsite septic system projects are in the application/planning phase; cultural resources surveys will be required on three of the projects and plans are to have one contract to complete the surveys. Board requested that Jennifer check in the Clallam County Environmental Health to determine if parcels with known septic issues can be "red flagged" so new, potential owners are aware.

Meghan – Reported that during the NPCLE ranking there was a funding deficit for the Sitkum Road 2900 SRFB grant proposal, however the US Forest Service thinks they can provide the matching funds so the culvert replacement project can be implemented. Also reported that she worked with three landowners this month to pursue on CREP riparian forest buffer planting projects on Matriotti Creek, Lotzgesell Creek, the Hoko River and Lamb Creek.

Joe – Reported that the Sequim Prairie-Tri Irrigation Association Evans Road Piping Project design is nearing completion with expected bid date in about a month. Some details with how to handle water savings required by the Irrigation Efficiencies Program while meeting Graysmarsh requirements are yet to be worked out. City of Forks rainwater harvesting demonstration project is coming along well.

# **NRCS Report**

Kirk delivered an update of this past month's events that included signing of two contracts for thinning trees. He has been working with Jenifer on the installation of soil moisture monitoring sensors.

Treasurer's Report

Robert Beebe moved to approve the July 2019 Treasurer's report and approve for payment of checks described as FF 10042-10057 and SB 283-285, electronic funds transfers, and direct deposits described as DD1021-DD1024 dated July 1-31, 2019 in the amount of \$68,123.43.

# **Cooperator and Cost-share Agreements**

Ben Smith moved to approve the cooperator agreement with Rolf Stahlbaum Robert Beebe seconded the motion. Motion approved unanimously.

Ben Smith moved to approve the cooperator agreement with Thomas Grunwaldt. Robert Beebe seconded the motion. Motion approved unanimously.

Ben Smith moved to approve a cost-share application with Thomas Grunwaldt to replace a failing onsite septic system at 100% cost-share rate for design and permits and a 75% cost-share rate for installation of the system, not to exceed \$32,500 total in cost-share funding. Contingent on obtaining grant funding through the Shellfish program.

Christy Cox seconded the motion. Motion approved unanimously.

Ben Smith moved to approve the cost-share application with Rolf Stahlbaum to replace a failing onsite septic system at 100% cost-share rate for design and permits and a 50% cost-share rate for installation of the system, due to nine-month residency. Total cost-share funding not to exceed \$21,000. Contingent on obtaining grant funding through the Shellfish program.

Christy Cox seconded the motion. Motion approved unanimously.

Ben Smith moved to approve the cooperator agreement with Katina Hester. Christy Cox seconded the motion. Motion approved unanimously.
